# Job Description

Miracles In Sight seeks a Surgeon Relations Coordinator (SRC) to serve as a conduit between Miracles In Sight (MIS) and their external clients. The SRC will pursue and maintain current knowledge regarding ophthalmological surgical trends and emerging techniques, cultivate and strengthen relationships with surgeons and other pertinent professionals by providing ongoing education, customized support, and timely communication, promote MIS core and specialty services, and work in conjunction with clinical services to optimize distribution outlets as identified in the Miracles In Sight strategic plan.

# **Essential Duties and Responsibilities**

- Maintains a working knowledge of general eye banking functions.
- Identifies target markets within Miracles In Sight service areas in accordance with organizational strategy utilizing familiarity with the eye banking industry and existing MIS reporting, tools, and dashboards.
- Support clinical wet lab demonstrations in operating rooms and training settings.
- Evaluates and interprets tissue distribution data and market demographics, ensuring that priorities are identified for both surgeon and recipient populations.
- Conducts proactive and responsive correspondence by utilizing the MIS CRM
- Assist in market analysis, implementation, marketing/communication, and training of new product lines.
- Completes face-to-face meetings with surgeons, schedulers, practice managers, and office staff, etc. to:
  - Ensure needs are identified and concerns are minimized.
  - Educate on MIS core and specialty services, enhancements, and new advances.
  - o Maintain image (community-centered, patient-first, leading-edge provider)
  - Offer excellent customer service.
  - Introduce new products/services/protocols.
- Maintains a book of business, as established by annual budget, and determines areas for growth.
- Work with the Manager of Surgeon Relations to set clear, attainable goals to expand and enhance MIS lines of service.
- Communicates opportunities, market trends, and issues to appropriate management/staff in a timely manner.
- Attends and exhibits at strategically pertinent local, national and international events, e.g., conventions, symposiums, courses, etc.
- Recommends improvements to the distribution system / process based on identified customer needs.

- Supports external users on the surgeon portal.
- Maintains a working knowledge of EBAA Medical Standards, FDA regulations, and all other industry relevant national and international standards and regulations.
- Serves as a professional representative of Miracles In Sight at all times
- Performs other duties as requested by the Manager of Surgeon Relations.
